# Warranty

## 10 Year Carpet Tile

---

Robert Malcolm warrants its commercial carpet tiles in accordance with the terms stated below for a period of 10 years from date of Invoice.

Robert Malcolm carpet tiles are warranted against excessive:

- Surface wear. A loss of more than 10% by weight of face fibre.
- Dimensional stability
- Delamination
- Static Electricity
- Edge ravel

If a product fails to perform as warranted, Robert Malcolm will correct the problem in the affected area either by repair or replacement with comparable product(s), at no extra charge.

The carpet tiles must be installed in accordance with New Zealand Flooring Standards. AS/NZS 2455.2:2007 Textile floor coverings - Installation practice, and must be maintained as recommended by Robert Malcolm. Cleaning and Maintenance guide can be found on our website.

We recommend carpet tile protector mats be used under Castor wheels.

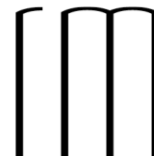
If a potential issue arises with wear performance, then you must notify the contractor/retailer in writing and allow them to carry out an independent inspection and appraisal. If requested, a sample showing the defect in the tile must be sent to Robert Malcom for testing to verify any claim.

This warranty does not cover tears, cuts, burns, pulls, or other damage or deterioration, problems or loss caused by neglect, misuse, improper maintenance, sporting equipment, flood/excessive moisture, excessive alkalinity, use under damaged castor wheels, or use on stairs not fitted with a commercial grade stair nosing. Robert Malcolms liability is limited to repair or replacement as stated herein. This warranty does not cover any problems or damages related to use of non-recommended adhesives.
